### RESTRICTIONS & CONDITIONS

- One-time support incentive is available from Showtime Networks Inc. ("SNI") for qualified properties that launch or renew SHOWTIME in bulk via cable or satellite between January 1, 2019 and December 31, 2019 (streaming platforms excluded).
- Qualified properties include 1) Lodging: hotels, motels, & timeshares; 2) Institution: hospitals & other approved institutions; 3) Multiple Dwelling Unit: apartment complexes, condos & homeowner associations; and 4) Universities; in each case that launch or renew SHOWTIME via cable or satellite, on a bulk-billed basis, in 100% of units.
- All qualified properties must purchase SHOWTIME on a bulk-billed basis at a non-discounted rate to be eligible.
- Properties are only eligible for one SNI support incentive.
- SNI reserves the right to determine property eligibility.
- Payment is based on a fully executed and binding contract with an authorized SHOWTIME distributor that clearly states SHOWTIME is a part of the entertainment package.
- Property must carry SHOWTIME, in bulk, for the entire term for which property is applying for support, for a minimum of 3 years; or Universities for a minimum of one year. If it does not, then property must reimburse SNI all launch or renewal support dollars received from SNI.
- Hotels and motels must make SHOWTIME available on a free-to-the-guest basis.
- Universities that launch or renew a 1 or 2 year contract are eligible for a \$1.80 per room incentive.
- SNI reserves the right to discontinue or modify this support incentive at any time by notice posted on SHO.COM/BULK.
- For launch support, property cannot have carried SHOWTIME at any time during the 90-day period immediately preceding January 1, 2019.
- Attach a copy of the executed contract with an authorized SHOWTIME distributor. Contract must include property's name, complete address, and number of units launching or renewing SHOWTIME. Form and contract must be received by SNI by January 11, 2020 for processing.
- All payments will be paid by check. Please allow 8-10 weeks for delivery of check.
- Submission of this form constitutes agreement to all terms, restrictions and conditions.
